As you might remember my goal is to have a full, free and fair debate on the cause of crooked teeth, it seems crazy to me that the orthodontic profession is treating 30-50% of the population, at great public cost and often with serious facial surgery, without knowing the cause of the problem, while also avoiding debate on the issue. Orthodontic therapy is generally based on an assumption of a genetic cause, while common sense and the weight of quality evidence in peer reviewed journals clearly concludes that this is mainly caused by the environment. While we cannot turn the clock back to live as our ancestors, simple public health messages targeted to children's groups and schools could make a significant difference to the health of the nation, especially since the link between crooked teeth, sleep apnoea, and several other health issues including ADHD is rising. This cannot be understated and their is so much more to what seems to be a just cosmetic issues of poorly aligned teeth.

It seems as if you could not make this stuff up, it is a real issue which is well supported by the hard evidence. Also I have cataloged the rejections letters that I have received from every single government and responsible body that I've contacted. Its seems that everybody thinks that this is someone else's problem. The GDC (general dental council) claims that I should approach the BOS (British Orthodontic Society) who do not want to debate this issue (some of their emails makes interesting reading) and as a self elected charity, it is not really their responsibility. Although the GDC held a debate on this very subject in 1922 they claim that their remit has changed and they can not longer enter or adjudicate on clinical issues.

Currently I am waiting on the GDC to give a response to a letter of mine that is due to be published in the BDJ (British Dental Journal). The editor has, as is standard practice, approached them to give them the opportunity to respond, so that their response is published directly after my letter. Obviously the wheels of the GDC turn rather slowly, especially as they are under great pressure after an attempt to raise the annual retention fee (the amount each dentist pays each year to be registered) by 64%, which is being fought tooth and nail. Having approached them my self about 6 times to three different chairpersons I strongly suspect that they will repeat the same response, that it is not within their remit to become involved in clinical issues.

My next step will be to send an open letter signed by quite a few prominent people in the field to the GDC stating that I will start a petition to GOV, asking that GOV to give the GDC the remit to hold a full, free and fair debate on this issue, or even some form of enquiry. This will obviously mean that I will have to go to the public with this issue, however I have exhausted all other possible avenues and will be whistle blowing a serious issue.

However I have just read that all petitions will be void soon as a new government is expected and they will not reopen until May 2015, which will delay the start of the petition. Although things do move slowly and I doubt that this will delay me too much, since we are bound to be waiting on other issues, and I cannot ethically mention anything to the public untill the second letter is delivered to the GDC and they have had a grace period to respond, and possibly reminded once with a deadline.

You mentioned that you might be able to help in January. This would probably be excellent timing, we will see how far we can get with Mumsnet just with the value of our argument and aim to be one of their campaigns of the week, which should help if the timing is right. I still feel that I have been hassling you to do something and can only defend this with the seriousness of this issue. It has taken me 6 years of constant letter writing to get to this point. Your support would be huge although nothing is going to stop me, I want the truth to come out.

Thank you very much for taking the time to read through all of this, I hope that it is not too wordy and makes sense. If you have time please send some form of response to indicate if you are going to be able to lend a hand at some point next year.




